Question

Could you please tell me how much has been spent on Northamptonshire Police/PCCs recruitment drive for special constabulary officers namely:

- -The start-up/design/maintenance cost of maintaining a standalone website for the project?
- -The cost of outsourcing the recruitment/application process?
- -What is the estimated cost of training each special?
- -Since September 2012 how many specials have passed started the training process and no longer serve with the force?

Answer

I am writing to advise you that, following a search of our paper and electronic records, I have established that the information you requested is held by this Department.

Could you please tell me how much has been spent on Northamptonshire Police/PCCs recruitment drive for special constabulary officers namely:

1. -The start-up/design/maintenance cost of maintaining a standalone website for the project?

Are there expected future costs for the website? The reply stated "costs to date" only, which was not my question.

£6,290 (ex VAT) has been paid to date. Northamptonshire Police have now begun the formal process of going out to tender for the future maintenance costs of the site. The tender will be published on the Force's website in due course.

- 2. -The cost of outsourcing the recruitment/application process?
- The outsourcing the recruitment / application process has been undertaken on an activity based costing model so we only pay for the activities that are undertaken.

The costs per activity (excluding VAT) are set out below:

- 3. -What is the estimated cost of training each special?
- The projected figure for taking each Special Constable through their initial training course up to attestation is approximately £300. The figure clearly does not take into account the ongoing learning and development that is expected of Special Constables in Northamptonshire Police
- 4. -Since September 2012 how many specials have passed started the training process and no longer serve with the force?
- 953 Specials started training and 266 of those no longer serve with the Force

If you are dissatisfied with the handling of your request, you have the right to ask for an internal review.
