I can confirm that the OPCC has identified three emails which are attached to this letter with information relating to third parties redacted. This information is exempt under section 40 (personal information) of the Freedom of Information Act (FOIA), as the information constitutes third party data. Section 40(2) provides that personal data about third parties is exempt information if one of the conditions set out in section 40(3) is satisfied. Under the FOI Act disclosure of this information would breach the fair processing principle contained in the Data Protection Act (DPA), where it would be unfair to the people to have their personal data released under these circumstances. This exemption is absolute with no public interest test necessary.

- 1. Community cohesion to ensure the school fosters a sense of community and brings diverse groups together.
- 2. Family cohesion it makes good family sense for children from one family to attend the same school.
- 3.Continuity of learning children's learning is enhanced and they make better progress in schools where there is a well co-ordinated curriculum and transition from primary to secondary phases of education.
